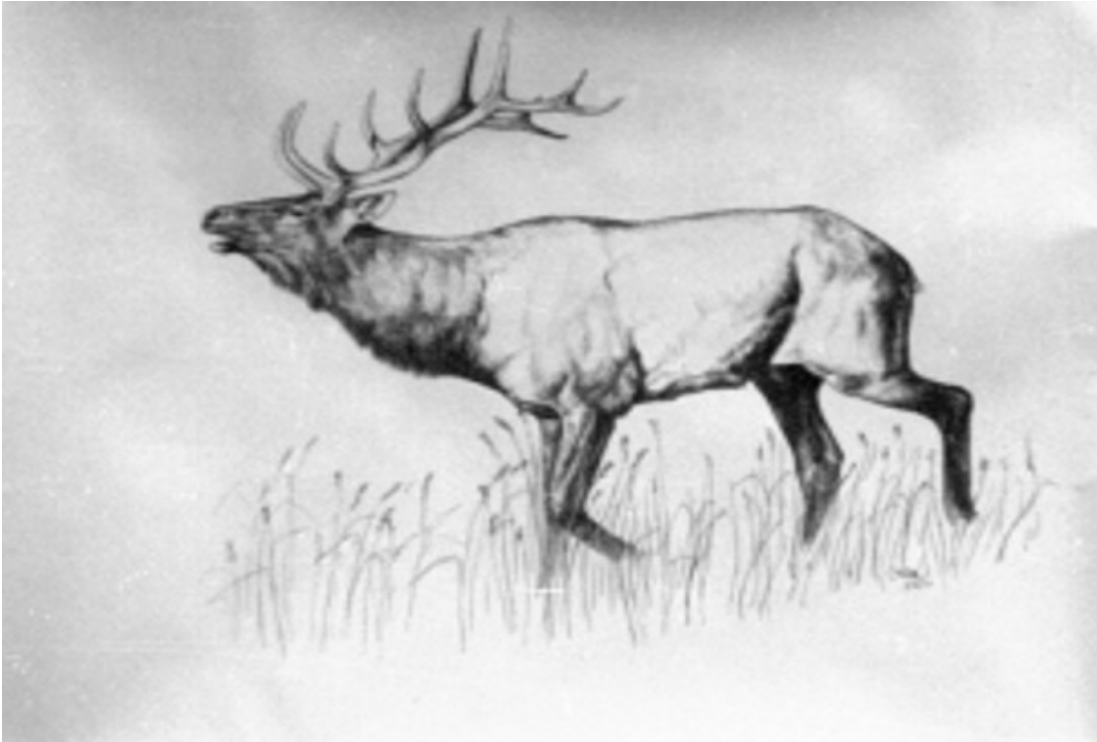

Exhibitors requiring forklifts to assemble displays or when uncrating, un-skidding, positioning and re-skidding equipment and machinery will need to estimate the needs below. A forklift is required for moving equipment of materials weighing over 200 pounds or more. If you require a forklift, a crew will be assigned consisting of a forklift with an operator.

**All orders are governed by the Oregon Party Rentals, Payment Policy and Limits of Liability and Responsibility.**

1. Oregon Party Rentals, and its subcontractors will not be responsible for ordinary wear and tear in handling of equipment, damages to uncrated materials, materials packed improperly, glass breakage or concealed damage. Claims for loss or damage must be submitted to Oregon Party Rentals, by the close of the show. No suit or action will be brought against Oregon Party Rentals or its subcontractors more than six months after the cause of action occurs.
2. Oregon Party Rentals, and its subcontractors will not be responsible for loss of, disappearance of, or damage to the Exhibitor's booth, nor are Oregon Party Rentals and its subcontractors responsible for Exhibitor's freight before it is picked up from the Exhibitor's booth for loading after the show. All bills of lading covering outgoing shipments submitted to Oregon Party Rentals, or its subcontractors by Exhibitor will be checked at the time of pickup from the booth and corrected where discrepancies exist.
3. It is agreed Oregon Party Rentals, and its subcontractors are not insurers. Insurance, if any will be obtained by Exhibitor. Amounts payable by Oregon Party Rentals, hereunder are based on the scope of liability as herein set forth and are unrelated to the value of the Exhibitor's property. It is further agreed that Oregon Party Rentals and its subcontractors do not provide for full liability should loss or damages occur. In the event that Oregon Party Rentals should be found liable for loss or damage to Exhibitor's equipment, the liability will be limited to the specific article that was physically lost or damaged. Such liability will be limited to a sum equal to \$.30 per pound/per article with a maximum liability of \$50.00 per item or \$1,000.00 per shipment, whichever is less, as agreed upon damages and exclusive remedy. Provisions of this paragraph will apply if loss or damage, regardless of cause of origin, results directly or indirectly to property through performance or nonperformance of obligations imposed by the offering of services to Exhibitors or from negligence, active or otherwise, by Oregon Party Rentals, or its subcontractors or their employees.
4. At the close of the show, if carriers fail to pick up or refuse to accept shipment, Oregon Party Rentals, reserves the right to reroute such shipment or move shipment to our warehouse pending advice from Exhibitor who will be charged accordingly for this service. No liability will be assumed as a result of such rerouting or handling. Thus, in order to expedite removal of materials from the show site, Oregon Party Rentals, will have the authority to change designated carriers, if such carriers do not pick up on time. Where no disposition is made by Exhibitor, materials will be taken to Oregon Party Rentals' warehouse to await Exhibitor's shipping instructions, and Exhibitor agrees to be responsible for payment of charges relating to such handling at the warehouse. Oregon Party Rentals, assume no liability as a result of such re-routing or handling.
5. Oregon Party Rentals, and its subcontractors will not be liable for shipments received without receipts, freight bills, or bill of lading, such as UPS or van lines, these shipments will be delivered to the booth without any guarantee of piece count or condition. No liability will be assumed for such shipments. Shipments received on separate days will be treated as separate minimum shipments.
6. Oregon Party Rentals, and its subcontractors will not be held liable, to any extent whatsoever, for any actual, potential or assumed loss of profits or revenues or for any collateral costs that may result from any loss, injury or damage to Exhibitor's materials or Exhibitor personnel which may make it impossible or impractical to exhibit same.
7. The Exhibitor agrees in the event of a dispute with Oregon Party Rentals, and its subcontractors relative to any loss or damage to any of the Exhibitor's freight or equipment, that the Exhibitor will not withhold payment in any amount due to Oregon Party Rentals, for freight handling services are any other services provided by Oregon Party Rentals and its subcontractors as an offset against the amount of the alleged loss or damage. Instead, the Exhibitor agrees to pay Oregon Party Rentals, prior to the close of the show for all such charges and further agrees that any claim the Exhibitor may have against Oregon Party Rentals, and its subcontractors will be pursued independently by the Exhibitor as a completely separate transaction to be resolved on its own merits.
8. Oregon Party Rentals, and its subcontractors will not be responsible for any loss, delay or damage due to events beyond their reasonable control which cannot be avoided by the exercise of due care and prudence, including without limitation, strikes, labor disputes, lockouts or work stoppage of any kind, fire, theft, windstorm, water, vandalism, act of God, mysterious failure of power or utilities, or other events.
9. The Exhibitor agrees, in connection with the receipt, handling, and temporary storage and reloading of its freight, that Oregon Party Rentals, and its subcontractors will provide these services as Exhibitor's agent and not as mailer or shipper. If any employee of Oregon Party Rentals and its subcontractors will sign a delivery receipt, a bill of lading, or other document, the parties agreed that Oregon Party Rentals, and its subcontractors will do so as the Exhibitor's agents, and the Exhibitor accepts the responsibility thereof.
10. Empty storage labels will be available at the Oregon Party Rentals, Service Desk. Affixing the labels is the sole responsibility of the Exhibitor or its representative. It is understood that these labels are used for empty storage only and Oregon Party Rentals and its subcontractors assume no responsibility or liability or loss or damage to contents while containers are in storage for mislabeled containers.
